

## **Competition Terms and Conditions**

BY INDICATION OF AND SIGNING THE REGISTRATION FORM I HEREBY UNDERSTAND AND AGREE AS FOLLOWS.

That this competition is run by volunteer individuals and is not a professionally run competition.

That this competition is open to boys and girls between 4 and 14 years of age only. (BORN 2014 - 2005)

To pay an entry fee of €10 (Ten Euro) per participant, and understand this is Non-refundable with no exceptions.

That by allowing my child to enter the competition, I consent to emergency medical treatment for my child while enrolled as a participant in the competition. I further agree and give the organizers my permission to administer first aid and in an emergency where I cannot be contacted to take my child for treatment at a medical facility where a medical practitioner will deem what treatment if any is necessary for the well-being of my child. I also accept that if medical consent is not given and agreed by me, my child will not be permitted to participate in the competition.

That the competition is staffed by enthusiast amateur volunteers who endeavor to meet the highest safety measures, however, I will not hold responsible the Cambridge F.C. Club nor any volunteer's for damages, injuries or loss of possessions of my child and that in giving consent for my child to enter the completion, I assume full responsibility and liability for any damages/injuries/loss of possessions whatsoever.

That the organizers shall not be responsible for any items lost or stolen during the course of the competition. (*We strongly recommend that all valuables be left at home*)

That my child must follow the instructions of the organizing staff in charge and understand that any misbehavior may result in my child being expelled from the completion and without objection from me.

That the organizers shall not be accountable should the competition be suspended or cancelled due to bad weather. In the unlikely event that inclement weather forces the cancellation I will seek no refund.

I also explicitly agree that in consideration of my child being allowed to enroll in the competition, I do hereby agree, for ourselves, our heirs, executors and administrators to release, hold harmless and forever discharge the Cambridge F.C club, volunteers, associated organizers, officers, administrators, agents, representatives, successors and assigns, for and against any and all claims, actions, causes of actions, suits, judgments, and demands whatsoever arising directly, or indirectly, in connection with the competition.

By signing the Registration Form I acknowledge that I have read and have understood this form and further understand that the terms herein are CONTRACTUAL and NOT a mere RECITAL.

### **Addendum:**

\* All participants in the competition may be used in photographic material for promotional purposes by the organizers. If the participating child is under a court order or is in the care of the health board the parent/guardian is strongly advised to inform the organizers of this in writing before the competition.

\* Failure to read these terms and conditions does not in anyway whatsoever relieve any parent/guardian from the conditions set forth herein, ignorance will not be considered a defense. It is strongly advised to copy this form for your own records.
