# **Privacy**

At St Patrick's GAA Club we respect your right to privacy. We understand the importance you place on the privacy and security of information that personally identifies you. In that respect, we have drafted this privacy policy to inform you what happens to the information that you supply to the club and how it is handled and processed. Naturally, **if you are not happy with this Privacy Policy, you should not proceed with giving information to the club.** We update this policy from time to time so please do return and review this policy regularly.

# 1. Collection and Processing of your Data by St Patrick's GAA club

We have set out below the instances where data is collected from you and in each case, what data will be collected, what the data is used for and whether any data is processed by third parties in each instance.

### **1.1 Club Membership**

#### Data collected:

When registering with the club we obtain personally identifiable information from you including your name, date of birth, telephone number and email addresses. Data of both players and/or their parents/guardians will be collected.

What the data is used for: The data collected is used to:

- allow for your registration with the club
- allow for your registration with the Gaelic Athletic Association, Ladies Gaelic Football Association, The Camogie Association and in turn, Servasport.
- contact you about training and match days
- contact you about fundraising within the club
- contact you about updates within the club or opportunities for tickets or club related activities.

### Data processed by third parties:

As noted above, data is transferred to the Gaelic Athletic Association, Ladies Gaelic Football Association, The Camogie Association for the purpose to registering players and club members with these bodies as well as our club. The GAA privacy polies can be found at which can be seen at <u>http://www.gaa.ie/privacystatement/</u> and <u>http://www.gaa.ie/news/privacy-notice/</u>. The GAA may store your data with Servasport. Details of servasport can be found within the GAA privacy policies already mentioned.

Registration through myclubfinances: To ensure efficiency, cost effectiveness and security in the registration and payment process, the Club use the services of myclubfinances for its club membership registration and payment. The details given through the myclubfinances website are given to the club and processed in line with this privacy policy. ### **1.2 St Patrick's GAA Easter and Summer Camps**

<u>Data collected</u>: When registering for camps, we obtain personally identifiable information from you including your name, date of birth, telephone number and email addresses. Data of both children taking part in the camps and their parents/guardians will be collected. We may also request any relevant medical information on the children as part of the registration process.

What the data is used for: The data collected is used to:

- allow for your registration with the club
- contact you about training and match days
- contact you about fundraising within the club
- contact you about updates within the club or opportunities for tickets or club related activities.
- Assist in ensuring the safety and appropriate care of you/your child during the camp

#### Data processed by third parties:

We do not process data collected as part of camp registration with any third parties. However, there are 2 instances where a third party will process your data with regards to the camps.

Kelloggs Cúl camps: Although Kelloggs Cúl camps are facilitated within the club, they are effectively ran by Kelloggs, who will be the data controller in this instance. Details of the Kelloggs Cúl camps can be found at <u>https://www.kelloggsculcamps.gaa.ie/</u>

Registration through myclubfinances: To ensure efficiency, cost effectiveness and security in the registration and payment process, the Club use the services of myclubfinances for its camps. The details given through the myclubfinances website is given to the club and processed in line with this privacy policy. #### 1.3 Fundraising

#### Data collected:

Data collected as part of fundraisers, including club lotto will include names, addresses, contact details and possibly the amount of monies donated.

#### What the data is used for:

Data collected in this way will be used for the purpose of the fundraising activity and to contact winners with regard to any prizes.

#### Data processed by third parties:

There are no third parties involved in processing of data for the club lotto and/or other fundraisers at present. Should a third party be involved, this will be clear from the fundraiser itself and you will be made aware of it at that time.

### **1.4 Online Club Shop**

There is an online club shop set up by O'Neills. ### 1.5 During course of relationship

During the course of your relationship with the club, other instances not covered in the aforementioned may arise where you share personal data with the club.. Examples include, details of matches played, attendance at training,

sale of match tickets and/or further information education and training provided by or through the club. You can be assured that such data will be protected in the same manner as all other personal data held.

**1.5.1 Photography:** Should you or your children be taking part in any club activities, including but by no means limited to Summer & Easter Camps or Social events, the club may from time to time take pictures of the activities or events for use on its website or Social Media pages (such as Facebook and twitter). Any data collected will be processed in line with the clubs privacy policy. If you do not wish for photographs to be taken, you must make the club aware of same.

**1.5.2 CCTV:** For the clubs own protection, there may be cctv in areas of the clubhouse and grounds. This will not include dressing rooms or shower and toilet facilities. You may appear on the cctv footage being taken. You can again be assured that such data will be protected in the same manner as all other personal data held.

## 2. Your rights

Under data protection law, the club may be classed as a 'Data Controller' and any person we obtain and process information on is a 'Data subject. Data subjects have various rights under the relevant legislation. These rights include, but are not limited to;

- The right to know if any personal data is held
- The right to a copy of the personal data
- The right to rectification of data
- The right to data portability.
