

**Please Read the following Terms & Conditions for:
Tallow GAA and Camogie Club 12
Days of Christmas Giveaway**



1. The promoter of the competition is Tallow Gaa & Camogie Club.
2. The competition's fundraising purpose is to raise funds for the development of Tallow Gaa & Camogie Clubs Gym.
3. The fundraiser will commence on Sunday 8th December 2024 and concludes Thursday 19th December 2024.
4. All prizes cannot be exchanged at any time for cash and non-cash alternatives.
5. The club can add additional prizes to the competition, and these will be notified to all entrants.
6. Only those who have bought an official ticket for entry to the draw will be eligible for the prizes. Tickets will not be sold to any person under 18 years of age. However, an adult can buy a ticket in Trust as a gift for someone under 18 years of age.
7. A maximum of 1000 tickets are available.
8. The club can change the competition draw date due to unforeseen circumstances, and entrants will be notified by social media.
9. All 12 draws will take place on the clubs social media.
10. The winners will be contacted within 48 hours of the draw. The prizes will be given out at a prize giving event in Pairc Eamonn De Paor
11. Winners may be required to provide additional personal information and proof of identity to claim the prize.
12. Once a ticket is purchased, no refunds will be issued unless the competition is cancelled.
13. The competition is conducted by the club, and entries and the final draw are independently observed and overseen by a third party.
14. The closing date for entry is the day before the competition first draw (7th December).
15. If the winner cannot be contacted or does not claim the prize within 14 days, the prize will be forfeited. In this case, the club will draw another winner under these same terms and conditions.
16. Winners may have their name and image used in publicity materials related to the competition.
17. The winner agrees to the publication, and any consents required to comply with GDPR/DATA Protection legislation are deemed to have been given on the purchase of a ticket for entry to the draw. Any personal data relating to any non-winning entrant will be used solely in accordance with GDPR and will not be disclosed to a third party without the entrant's prior consent.
18. The prize is not transferable.
19. Flights must be booked between 1st January 2025 and 31st December 2025, flights are only available to the location promoted on this prize: Las Vegas.
