DATA PROTECTION - INFORMATION ON CONSENT

YOUR RECORDS The information we record will be used only for the following purposes:

For membership of Glen Rovers and the GAA we are required to collect the following information from you;

- Name, To register you as a member of the club and the GAA
- Address, To send you club information regarding meetings
- Phone and email Address, To send you text and emails containing club reports.
- Date of birth

We do not share any personal identifying information (such as name or address) with any other public agencies and bodies except the GAA

WHAT IS PERSONAL DATA?

Personal data is data which can be used to identify you. This may include your name, date of birth, address, telephone number etc.

WHAT IS A DATA CONTROLLER?

A Data Controller is someone who is responsible for your data and who must make sure that your data is processed according to the law. For example, they are responsible for making sure that the information held about you is accurate and that it is kept secure. You have the right, given by the Data Protection Act of 1988 and 2003, to a copy of your personal

information at any time. You can get this by contacting us through the club Secretary.

CAN I WITHHOLD MY CONSENT?

Yes you can. We will not record your information unless you provide your consent for us to do so. However we will not be in a position to send you notification of club events as outlined above as a result.

PERMISSION TO STORE YOUR DATA

We are required by law to ask for your permission to record your details and the details of our supports to you. These details may contain your personal data as provided by you. Paper copies of your data may also be stored securely by us
