MEMBERSHIP NOTES:

1. MEMBERSHIP FEE PAYMENT:

- Membership fees must be paid in full by March 31st 2022.
- If paying by the instalment option, the first instalment must be paid on/before January 31st 2022 to ensure full payment of all instalments by March 31st 2022.
- Failure to pay in full by March 31st 2022 results in members not qualifying for voting rights or inclusion in the All Ireland Hurling and Football ticket draws.
- Fees must be paid in full by March 31st 2022 to ensure players are insured and registered with the GAA/LGFA/Camogie Association. Unregistered players will not be permitted to train or play after March 31st 2022.

(ii) Completion and return of a signed membership form.

Forms and fees should be returned to club Registrar/Team mentor/Executive committee member.

2. MEMBERSHIP TYPES

3. AGM VOTING RIGHTS

- In line with GAA Rule 6.2 and 9.1, only Full Members paid in Full on/before 31st March 2022 will be eligible to vote. Social membership does not entitle the member to voting rights.

4. ALL IRELAND HURLING AND FOOTBALL TICKETS

- Eligibility for inclusion in the draws for tickets will be based on meeting one or more of the following criteria:
 - (i) Having **full membership** (reference NOTE no. 2) which has been **paid in full on/before 31st of March 2022** (reference Note no.1).
 - (ii) Having an **Annual Lotto Subscription** which has been **paid in full on/before 31st of March 2022**.
- The annual lotto subscribers will enter a separate draw where 25% of the clubs total allocated tickets will be assigned. Each annual lotto subscription qualifies for one All Ireland draw entry e.g. A three entry lotto subscription entitles the player to three entries into all Ireland draw.
- The allocation of remaining tickets is divided into two further draws (i) club trustees, executives and mentors, and (ii) eligible full members.

- Social memberships (associate and nursery) will only qualify for inclusion in the All Ireland Ticket Draws when an annual lotto subscription is also purchased.
- In the event of a replay, the original drawn members are also allocated replay tickets (where the same number of tickets have been issued to the club).
