The following Privacy Information is being provided to you as outlined in the General Data Protection Regulation. It is intended to inform you of how the Personal Information provided on the registration form will be used, by whom and for what purposes. ### Who is the data controller?

### What is the purpose of processing my Personal Data?

The purpose for processing your Personal Data is facilitate your booking for the facilities provided by Fossa GAA Club. The purpose is also to keep you informed of GAA events and fundraisers. We will only use your personal data for this second purpose if you have provided your explicit consent for this by ticking the relevant boxes.

### Will anyone else receive a copy of my Personal Data?

Your Personal Data can be accessed by certain members of the Fossa GAA Club Committee. This will be done in accordance with our data protection policy only.

### Where is your Personal Data stored?

Your data will be stored electronically and/or in hard copy format on a secure database and/or filing system which is located with the Fossa Gaa Registrar.

### How long will your Personal Data be stored for?

Some Personal Details including Name and purpose of booking are held for 2 years for statistical purposes. If you have given consent for us to you regarding Club activities, we will retain your information for a maximum of two years, during which period you will be given the opportunity to renew or withdraw your consent.

### How can I obtain a copy of the Personal Data held by the Club/GAA?

You have the right to request a copy of all of your Personal Data and can do so by contacting us. This information will be provided to you within one month.

### What are my privacy rights relating to my Personal Data?

You have the right to have your Personal Data updated, rectified, or deleted if you so wish. You have the right to object to your Personal Data being processed and to withdraw your consent to processing - You can do so by contacting us.
