Parents/guardians of all Killorglin CYMS underage participants & all senior players (each category) should familiarise themselves with the content of these guidelines.

Due to the dynamic nature of the Covid-19 pandemic, parents/guardians & senior players should return to the above link on a regular basis and carry out a review for any updates that may be posted.

Killorglin CYMS Basketball Club will use its best endeavours to follow in full all relevant Government, Basketball Ireland & Sport Ireland guidelines.

Parents/guardians/senior players should understand that in utilising the Clubforce App, the information as entered will be used in the event of Covid-19 contact tracing being required during the course of the basketball season. Players at all levels will be invited to training via the messaging facility on the Clubforce App. In advance of every training session & competitive games, it will be mandatory to self-appraise the medical condition of the attendee in relation to Covid-19 symptoms. In doing so, a declaration that no symptoms exist must be confirmed on Clubforce. The declaration is required to ensure, as far as practically possible, the safety of all coaches & players. Failure to complete this declaration will prohibit attendance/participation at the relevant training session/game.

In advance of any return to play, all parents/guardians must acknowledge the inherent risks associated with participating in sport during the COVID-19 pandemic. In doing so, the Executive Committee of Killorglin CYMS Basketball Club will require a full and unqualified waiver in relation to any such risks.

I/my child/family acknowledge that I/we must comply with all set procedures to reduce the spread while availing of the basketball coaching/facilities being provided by Killorglin CYMS Basketball Club.

I hereby release and agree to hold Killorglin CYMS Basketball Club harmless from, and waive on behalf of myself, my heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself/my family and/or property that may be caused by any act, or failure to act associated with the activities of Killorglin CYMS Basketball Club.

I understand that this release discharges Killorglin CYMS Basketball Club from any liability or claim that I, my heirs, or any personal representatives may have against the Club with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to COVID-19 and the associated activities of Killorglin CYMS Basketball Club.
