



## Milltown GAA New York Draw (2024) Terms & Conditions

1. Flight departs Dublin Airport on 30th November at 9 am, arriving in Newark Airport 30th November at 11:50 am local time.
2. Flight departs Newark Airport on 4th December at 7:15pm local time and arrives in Dublin Airport at 7am on 5th December.
3. Hotel Transfers are **not** included.
4. Accommodation is 4 nights in 4 star Hotel Eddison, Double room with Queen Bed. Grab & go breakfast included. Local charges may apply and are **not** included (ie city tax, resort fees, gratuities, parking etc.)
5. Travel Insurance is **not** included.
6. Flights and travel dates are non-transferable.
7. No cash equivalent prize

13. Permit is granted for this raffle
14. The fundraising purpose of the Raffle is to raise funds for the upgrade of facilities at Sean Doolin Park, Milltown, Co. Westmeath. Upcoming projects are part funded but required match funding from Milltown GAA. All proceeds will only be used for that purpose (incl. costs associated with the organisation and running of this Raffle) and the organisers of the Raffle shall not derive any personal profit from the Raffle.
15. The Prize is, as stated, a trip for 2 to New York. Departing on 30<sup>th</sup> November 2024 and returning on 4<sup>th</sup> December 2024. Direct flights from Dublin airport to Newark Airport. 20KG bag included. Accommodation is 4 nights in 4 star Hotel Eddison, Double room with Queen Bed. Grab & go breakfast included. Travel insurance and hotel transfer is **not** included. The trip is organised through Cassidy Travel and as such the winner will liaise with Cassidy Travel as soon as soon as possible to transfer ticket into their names. **Names need to be transferred to the tickets no later than Friday 18<sup>th</sup> October.**

(d) The Winner hereby also agrees and consents to his or her personal data being released to relevant third parties to affect the transfer of the prize to him or her.
